Addendum to Adoption Agreement For The Rescue Of Gentle Giant Large Breed Dog

This is an additional requirement of the Agreement dated 11/12/2006 between Gentle Giants Rescue and Adoptions, Inc. ("Rescuer") and _____ ("Adopter") regarding the adoption of an Adopted dog described as follows:

White with Carmel spots Weiffhard, Becherhard Boyer Greyhound
male puppy, 5 1/2 months + to be neutered at 6 months

This dog is to be _____ spayed neutered by 12/1/2006 Rescuer is required to spay and/or neuter all dogs immediately after attaining the age of 6 months. I, the Adopter, agree to undertake this responsibility to have the dog that I am adopting spayed and/or neutered (surgically sterilized) no later than the above required date. In most cases, the Adopter will be required to bring the Adopted Dog back to be spayed/neutered at Norco Animal Hospital - (951) 736-1917 as per the appointment set by Rescuer, c/o Tracy Ward. I, the Adopter, agree to bring my Adopted Dog to its spay and/or neuter appointment and I realize that this a material requirement of my Adoption Agreement.

If I, the Adopter, choose to have my Adopted Dog spayed and/or neutered at another veterinarian, then, I, the Adopter, am required to leave a spay/neuter deposit check made payable to Rescuer to cover the cost of this spay/neuter at the time that I adopt a dog from Rescuer. I, the Adopter, further agree to send Rescuer proof of spaying or neutering within 5 days after this spay or neuter has taken place, which shall include a fully completed spay or neuter certificate with the name and phone number of a licensed veterinarian who performed the operation, so that Rescuer can obtain verification. After Rescuer verifies that this Adopted Dog has been spayed or neutered, Rescuer will return or destroy Adopter's deposit check.

I, the Adopter, also agree that if I fail to meet this requirement of the contract and do not spay or neuter this Adopted Dog as I have promised and as is required, Rescuer will cash the spay/neuter deposit check and my spay/neuter deposit will become non-refundable. Further, I, the Adopter, will also relinquish all ownership rights to this Adopted Dog, and ownership will immediately revert to Rescuer, and I agree to bring this Adopted Dog back to Rescuer immediately, so that it be placed in another loving home. I, the Adopter, understand that if I do not comply with this requirement, I will relinquish ownership of this Adopted Dog and physically return it to Rescuer, and I further understand that I will have no claims against Rescuer, its management, employees and workers whatsoever, and that I will receive NO REFUND WHATSOEVER.
